#### Key Dates for 2025-2026 Board Term Elections

- **Monday 30 September** – Notice of AMEC AGM and election details posted on AMEC website.
- **Monday 30 September** – Email notification to all active members
- **Monday 14 October** – Deadline to submit Nominations and Personal Statement forms.
- **Wednesday 16 October** - AMEC announces nominations and open ballots, if required, e.g., if nominations exceed the number of vacancies in each membership category.
- **Wednesday 30 October** - Ballot closes (if called)
- **Wednesday 6 November** - AMEC AGM – election results ratified and announced.
- **Sunday 1 January 2025** – BOD Two Year Term Commences
- **Thursday 31 December 2026** – BOD Two-Year Term Ends

#### Essential information for prospective Directors

- All the information about the Elections, including Election procedure, will be available on the AMEC website here from **Monday 30 September 2024** for the opening of the elections.
- Deadline to return completed nomination and manifesto forms **Monday 14 October 2024**.
- Members may only nominate and vote within their own membership category\*. (Ballots will be distributed 16 October to members in member categories with vacancies and only reflect candidates in the category)
- All members can vote in this election for their respective membership category BOD vacancy.

- Nominees are responsible for the accuracy, completion and timely delivery of the nomination form and the manifesto form available on the AMEC website <hyperlink once built>. Late ballots will not be accepted.
- The election Manifesto/Personal Statement is particularly important and gives candidates the opportunity to summarize their industry career, company role and more importantly why you want to join the Board and your planned contribution(s) to growth and work of AMEC.
- Directors are elected for a two-year term.
- The AMEC Board meets a minimum of 5 times a year – 3 meetings by conference call with two in- person meetings (where possible). The in-person meetings for 2024 are planned to be held prior to the start of the 2025 AMEC Global Summit in Vienna, June 2025, and again in London at the AMEC AGM and Q4 Board Meeting in November.
- There is no guarantee that members who put their names forward will be elected. In many categories, we receive more nominations than we have available Board seats. A ballot vote will be held, and seats filled by the member receiving the most votes in this circumstance.

**The election process for members**

- You can self-nominate or ask another AMEC member to nominate you, provided that, the member is in good standing and is from the same membership category as your company.
- **There are two documents to complete and return by MONDAY 14 OCTOBER 2024.**
  - **AMEC Board Nomination Form**
  - **AMEC Election Manifesto**
- As nominations and personal statements are received, they will be added to our election website page for member review.
