AMEC Procedure for the Election of Chapter Leadership: 2025-2026

AMEC seeks nominations from members in good standing, who wish to volunteer for the Asia Pacific region position, who will represent the Chapter on the AMEC Board. This person agrees to attend AMEC BOD meetings and hold a minimum of one meeting each quarter with members in the region.

We recommend each regional Chapter has a team of Chair and Co-Chair, both will support the Chapter Chair in planning and executing regional meetings and events and each are invited to represent the Chapter at AMEC Board meetings.

Candidates are eligible to run for both Board Director and Chapter Director elections.

Important Expectations for AMEC Chapter Leadership teams 2025-2026

The goal of the AMEC region is to bring members together in collaboration to address unique regional challenges which support the members and the industry at large. These learnings can also help guide the overall industry maturity and serve as resource development in advancing the industry generally and specifically related to the understanding and practice of measurement and evaluation including, but not limited to, data analysis data integration and technology advancements.
